## Selection for Nurse Practitioner in Midwifery – Educator (NPME) course at National Midwifery Training Institute, Patiala

Online applications are invited only from eligible in-service candidates (both from regular Staff Nurses and CHOs - regular CHOs and contractual CHOs under Department of Health & Family Welfare, Punjab and under State Health Society, NHM Punjab and regular Staff Nurses under Directorate of Research and Medical Education, Punjab) for selection as Nurse Practitioners in Midwifery – Educator (NPM Educator) course at National Midwifery Training Institute (NMTI), Patiala.

Required educational qualifications and relevant experience is as follows:

#### Qualifications and Experience:

M.Sc. Nursing with a speciality in obstetrics and gynaecology, paediatrics or community health	Minimum 2 years of clinical experience in maternal care
B.Sc Nursing/Post Basic B.Sc Nursing/ M.Sc Nursing (any other speciality except gynaecology, paediatrics or community health)	Minimum 5 years of clinical experience in maternal care

- Candidates must have passion towards Midwifery, clinical/hands-on experience in conducting deliveries and willingness to continue the clinical practice and conduct deliveries.
- Candidates with teaching experience in Obstetrics and gynaecological nursing, Paediatrics nursing and community health nursing will be given preference. Research experience is an added advantage.

#### Selection Terms:

- The candidates shall be selected as per the criteria laid down by the Government of India.
- Only in-service staff nurses of DHS/DRME/NHM Punjab and Community Health Officers (CHOs) under State Health Society, NHM Punjab as per the eligibility criteria can apply. Private candidates/staff nurses are not eligible to apply.
- This application is to be considered for entry into 18-months Nurse Practitioner in Midwifery Educator (NPME) course that is being run by the State Health Society under the overall aegis of National Health Mission, Punjab.
- The selected candidates would undergo first six months of intensive residential training at National Midwifery Training Institute (NMTI) Patiala followed by one year clinical training and onsite mentorship at either NMTI or identified State Midwifery Training Institutes (SMTI)/hospitals with Midwifery led model of care in Punjab to ensure proficiency as Midwifery Educators. (6 months at NMTI Patiala + 12 months onsite clinical mentorship and training at NMTI/any SMTIs/MLCUs in Punjab)
- Three State Midwifery Training Institutes (Jalandhar, Gurdaspur, Ropar)
  are notified in Punjab, and candidates after the completion of the first six
  months of residential training can be posted at any of these sites to run
  the Nurse Practitioner in Midwifery (NPM) course and make functional
  the Midwifery Led Care Units (MLCU) in Punjab.
- Candidates from district Patiala, Ropar, Gurdaspur and Jalandhar will be given preference.

#### Monthly Remuneration:

- Remuneration for selected in-service candidates (whether DHS cadre staff nurses or DRME cadre staff nurses or NHM cadre staff nurses or Community Health Officers hired under NHM Punjab) will be borne by their parent department i.e., DHS/DRME/NHM Punjab, as the case may be. There will be no break in their career/previous service.
- Tuition fees and boarding & lodging during the first six months' of residential training at NMTI Patiala for the selected candidates would be borne by NHM Punjab for all selected candidates.
- An additional allowance of Rs. 15,000/- per month during the entire duration of the course (18 months) will be given to all candidates who join the course.

#### Other Requirements:

- · Only female candidates can apply.
- · Maximum age limit is 45 years at the time submission of application.
- Must be a registered R.N.R.M. with Punjab Nurses Registration Council and should furnish an active registration certificate.
- · Clinical/hands-on experience in conducting deliveries.
- · Proficiency in basic computer usage-MS Office, use of Internet etc.

#### Other Terms and Conditions:

- · Candidates must be of Indian Nationality.
- The selection shall be as per the criteria laid down by the Government of India.

#### SERVICE BOND:

- Selected candidates are required to submit a written undertaking to work/serve with the Govt. of Punjab for five years as Midwifery Educators after successful completion of their training. An affidavit in this regard has to be submitted at the time of final selection for serving in the midwifery cadre.
- Willingness to shift to Patiala, Punjab during the training period and to the training facilities after completing their training, whichever is notified in Punjab.
- Appointment of candidates will be subject to their willingness in writing to be stationed in the identified facilities.
- Applications containing wrong claims with regard to basic educational qualification/eligibility/ age and other basic eligibility criteria shall be liable for rejection.
- NHM Punjab will not be responsible for any consequences arising out of furnishing incorrect and incomplete details at the time of submission of online application.
- All essential/original documents will be verified as per NHM norms during the time of counselling.

### Note:

- Numbers of seats can vary. Mission Director NHM reserves the right to cancel the entire process at any stage without issuing any notice or may cancel screening process due to administrative reasons.
- The date, time and venue of the written test shall be communicated to all candidates through NHM website.
