5. Method of Recruitment:

Recruitment shall be done by the District Selection Committee on behalf of the concerned District Health Society, for all the vacant positions.

For the posts of MLHPs. the guidelines for recruitment issued by CH&FW this Office in Lr.Rc.No.96/NUHM/HWC/NHM/2017, dated: 06.09.2022 shall be followed (For age the guidance issued at "3) Age "shall be followed).

Other than MLHP positions, the following guidelines shall be followed:

6. Selection will be done on Merit Basis and based on the following criteria:

- (i) Merit Lists shall be prepared separately for each of the categories of posts.
- (ii) Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for the age. Weight-age for age will be reckoned from 18 years of age of the candidate.0.5 mark will be awarded for one completed year of age with a maximum of 10 marks. The age will be reckoned as on01-07-2024.

Example (1). If a candidate completes 20 years as on 01-07-2024, he/she will be awarded 1.0 mark,

Example (2.) If a candidate completes 30 years of age as on 01-07-2024, he/she will be awarded 6.0 marks,

Example (3.) If a candidate completes 40 years of age as on 01-07-2024, he/she will be awarded10.0 marks).

- (iii) Merit list will be prepared based on the marks obtained with above criteria and displayed on Official website (https://gadwal.telangana.gov.in) of the District Collector, Jogulamba Gadwal for transparency and also for calling objections.
- (iv) Selections list will be prepared from the finalized merit list duly following the Rule of Reservation (RoR) and Presidential Orders.
- (v) The Selected candidates shall maintain the Headquarters.
- (vi) These positions are not transferable.

7. Rule of Reservation:

- (i) Rule of Reservations in respect of Community, Disability, Ex-Service Men/Women shall be strictly observed as ordered by the Government of Telangana from time to time.
- (ii) 33 1/3% reservation for women will be applicable as per the orders issued by Government in G.O.Ms.No.3 Dept for Women. Children, Disabled & Sr. Citizens (Prog. 1) dated 10.02.2024 and in GO.Ms.No.35, Genl. Admn. (Ser. D) Dept., dated 13.02.2024.
 - (iii) The Rule of Reservations to local candidates is applicable as per the Presidential order.
- (iv) The vacancies for the posts mentioned in G.O.68, falling in Scheduled Areas should be filled exclusively with the Local Scheduled Tribes.

It is to inform 1st reference cited, Government has accorded permission to recruit posts of vacant MLHPs for which Government approval is already available Further in supersession of orders issued in reference 2nd & 3rd read above, Government has approved selection procedure for filling up of Mid-Level Health Provider (MLHP) posts on contract basis.

- In this regard, the District Selection Committees headed by District Collectors are requested to take necessary action to fill up these vacancies on contract basis. Guidelines for recruitment are appended to this letter.
- It is further informed that as per Government of India guidelines BUMS, BHMS 3. and BNYS candidates are not eligible to hold the post of MLHP. It is therefore, requested to terminate the existing MLHPs with the above qualification after serving mandatory notice as per rules.
- It is requested to show personal interest and complete the recruitment process as per the timelines given following the guidelines enclosed.

Guidelines for recruitment of Mid Level Health Providers (MLHPs) on contract basis

- Applications shall be invited by the respective District Selection Committees headed by the District Collectors.
- 2) Selection shall be done as per the following priority:
 - (i) MLHP posts of Sub centres (HWCs) that are located in municipal areas should be filled with MBBS/BAMS doctors only with preference being given to MBBS doctors.
 - (ii) MLHP posts of Sub centres (HWCs) that are located in other than municipal areas, the recruitment shall be done in the following order of priority
 - (a) Doctor (MBBS/BAMS), with preference being given to MBBS
 - (b) Staff Nurse with B.Sc (Nursing) who have graduated from the academic year 2020 onwards (or) Staff Nurse with B.Sc (Nursing)/GNM who graduated before the academic year 2020 and who completed 6 months bridge programme in Community Health (CPCH)
- 3) The district wise number of vacancies in Health and Wellness Centres for recruitment located in municipal area is appended as Annexure-A. The district-wise number of vacancies of for recruitment Health and Wellness Centres located in non-municipal areas is appended as Annexure-B.
- 4) In the Health and Wellness Centres located in municipal areas, the positions will first be filled up with MBBS doctors as per eligibility. After exhausting the MBBS doctors, these vacancies will be filled with BAMS doctors as per eligibility.
- In the Health and Wellness Centers located in non-municipal areas the positions will first be filled up with MBBS doctors as per eligibility. After

exhausting the MBBS doctors, these vacancies will be filled with BAMS doctors as per eligibility. If no doctors are available, then these positions can be filled up by Staff Nurses as per the eligibility.

6) Age: As prescribed by government the minimum and maximum age is 18 years and 44 years respectively. The upper age limit prescribed above is however relaxed in the following cases:

9) District Selection committee (DSC)

Recruitment shall be done by the District Selection Committee on behalf of the District Health Societies.

10) Selection Procedure

- (i) Selection will be done based on the combined percentage of marks obtained in all Years of MBBS/BAMS/B.Sc Nursing/GNM
- (ii) Rule of reservation shall be followed as per government orders from time to time.
- (iii) Presidential Order-2018 has to be followed. As per Presidential Order-2018, MBBS and BAMS doctors are multi-zonal posts and Staff Nurses are Zonal posts.
- (iv) Since Health and Wellness Centers located in municipal areas are to be filled up by only MBBS/BAMS doctor, they will be permitted to opt for either urban or rural Health and Wellness Centers or both.
- (v) Notifications shall be issued by DSC

- 12) The selected MBBS and Staff Nurse candidates have to undergo two weeks of induction training. The selected BAMS candidates have to under-go bridge course programme in Community Health (CPCH).
- 13) After selection process is completed, postings will be issued to the identified Health and Wellness Centres as per merit cum options
- 14) The list of HWCs to be filled up in urban/rural areas as per para 13 above will be communicated in due course
