Further the following are the terms and conditions for engaging ITI passed apprentices:

 Age limit: The minimum age limit is 18 years, and the maximum age limit is 30 years for General and EWS Category as on closing date (Relaxable by 05 years for SC/ST & 03 years for OBC (Non-Creamy layer) & 10 years for 40% or more PWD Candidates (VH/HH/OH) in their category.

- Stipend: As per provisions of apprentice Act 1961 (Rs.7000 /- Per Month).
- Training Duration: One Year.
- The defined seats of reservation for SC, ST, will be as per Apprentice Act 1961, in the ratio of 1:6 and 1:3 respectively. Reservation for OBC and PH Candidate will be given as per the norms of Uttarakhand Government.
- Preference will be given for candidates from project affected families (PAF) and project affected areas (PAA) of Tehri, Koteshwar, Pipalkoti.
- Only Candidates who have Uttarakhand Domicile are eligible to apply.
- Candidates should be eligible with respect to age criteria and educational qualification as on closing date. Result awaited candidates need not apply.
- Employment in THDCIL: No Employment will be given after the completion of apprenticeship training by THDCIL.
- Candidates will have to make their own arrangements for stay & transportation.
- The candidates who after completion of their education have already undergone apprentice training in any organization shall not be considered eligible for apprentice training.
- Selection criteria: There will be no interview; the eligible candidates will be shortlisted based on merit drawn based on marks obtained in respective trade i.e. ITI examination. (in case the marks obtained by the candidates are same, then candidate of higher age will be given preference).
- Application is to be submitted with following documents duly signed by the candidates.
- SSC/ Matriculation Marks sheet and Certificate
- ITI marks with Certificate
- Proof of date of birth (Matriculation Certificate)
- Caste Certificate, if applicable
- Certificate of physical Disability/PH, if applicable
- Character certificate

- Certificate of Project Affected Family/ project affected area.
- Aadhar card (mandatory)
- Registration Number- Print out of registration number generated on www.apprenticeshipindia.gov.in portal.
- Candidate must submit Medical Fitness Certificate obtained from Medical Officer (Gazetted).
- Those candidates who have successfully completed ITI (Regular) in 2022,2023,2024 are
 only eligible for apprenticeship Training. Candidates whose results are awaited will not
 be eligible for applying for apprenticeship training.
- The selection and deployment of apprentice trainees will be subjected to detailed provisions.
- Candidates may kindly ensure that they possess required qualification for the
 apprenticeship training, if at any time of joining or after joining apprentices training it is
 found that candidates have submitted wrong information, or the documents submitted
 are not true the candidature of the candidate will be cancelled without giving any
 reason.
- Management reserves the right for amendment/ rescheduling/termination/suspension
 of selection process without giving any reason.
- No communication will be done with the candidates who have not been selected.
- Corrigendum/Modification /updation related to selection process will be made available in the recruitment section of THDCIL website: www.thdc.co.in. No information in this regard will be given or will be published in newspaper or through any other medium.
- Candidates are advised to check the website regularly for updates related to the engagement of Apprenticeship Trainee in THDCIL.
- For EWS Candidate: Candidate not be covered under the reservation scheme for SC/ST/OBC-NCL. Have a family gross annual income below Rs.8.00 Laks including income from all sources for the Financial Year prior to the year of application.
- For OBC Candidate: OBC applicants are required to upload OBC caste certificate with NCL certificate valid for the current year issued by the Competent Authority in Central Govt. Format.
