Applications are invited from the eligible Indian Citizens who are Natives/Residents of the Union Territory of Puducherry for the open written Competitive Examination to be held for Direct Recruitment to the post of Junior Engineer / Assistant Motor Vehicles Inspector (Group 'B' Non-Gazetted — Non-Ministerial) in the Transport Department, Puducherry as detailed below:

Instructions to candidates who have applied earlier in response to the notification No.5663/TD/Estt./E5/2022 dt.10/11/2022 of the Transport Department, Puducherry:-

All the applications received earlier in response to the notification dated 10.11.2022 were screened restricting only with respect to the Driving license authorizing to drive motor cycle, Heavy Goods vehicles and Heavy passenger motor vehicles and the list of applicants found eligible to participate in the open written competitive examination is attached herewith as Annexure-I and also made available in the recruitment portal. The other eligibility conditions as per clause (2) of this notification shall be verified after the Declaration of open written competitive examination results.

THOSE eligible applicants listed herewith as Annexure-I and also listed in the Recruitment portal NEED NOT APPLY AGAIN. Their age eligibility criteria will be reckoned as per the cut of date notified earlier on 10.11.2022.

- 1. The rejected applicants may login to the recruitment portal to know the reason for their rejection. Further, if they are found eligible consequent upon the present notification, they may apply afresh.
- 2. The accepted/eligible applicants listed and attached herewith as Annexure-I are hereby strictly instructed to verify their sub-categories under which they fall, due to the modification in the vertical reservation in the recruitment notification. Moreso, if any candidate fail to verify his respective sub-category within the stipulated time, it will be presumed that he has waived his right in this regard and any claim in future will not be entertained.
  - 3. The candidates who have already applied and are short listed based on eligibility criteria mentioned in the Annexure-I, are required to update their respective category as detailed below:
    - (a) The candidates who had applied under UR category in the earlier notification shall change their category as EWS if they fulfill the criteria prescribed for EWS category.
    - (b) The candidates applied under OBC category in the earlier notification shall change their category as MBC if they belong to MBC.

(c) As no posts were earmarked for EBC, BCM and BT in the fresh notification the candidates applied under OBC category in the earlier notification shall change their category as UR if they fulfill the age criteria of UR category as per the earlier notification.

Only first email will be accepted for category updation and multiple email will result in rejection of candidature.

### Important Note:

Candidates who have applied under OBC category in the earlier Notification and who actually fall under EBC, BCM, BT etc, categories and who are not fulfilling the age criteria under UR category will be summarily rejected.

### 2. Eligibility Conditions:

Applicants should posses the following qualification and experience as on **28.02.2025** 

### 2.1 Educational / Technical qualifications / Experience required:

(i) A Bachelor's Degree in Automobile or Mechanical Engineering from a recognized University.

### And

(ii) Driving license authorizing to drive motor cycle, heavy goods vehicles and heavy passenger motor vehicles.

#### Or

- (i) A pass in 10<sup>th</sup> Standard from a recognized board/University;
- (ii) A Diploma in Automobile Engineering (3 years course) or Diploma in Mechanical Engineering (3 years course) awarded by the State Board of Technical Education;
- (iii) Work experience of one year in an automobile workshop of manufacturing unit or authorized service centre of manufacturing unit which undertakes repairs of both Light Motor Vehicles, Heavy goods vehicles and Heavy passenger Motor vehicles fitted with petrol and diesel engines;

#### And

(iv) Driving License authorizing to drive motor cycle, heavy goods vehicles and heavy passenger motor vehicles.

### **EXPLANATION:** "Automobile Workshop" Shall mean

a. An automobile workshop owned by the Government or the State Transport Corporation.

(or)

b. An Automobile Workshop recognised or approved or certified by the Transport Department or Motor Vehicles Maintenance Department for Carrying out all kinds of repairs.

(or)

c. Any authorized service centers of a vehicle manufacturer.

NOTE: All the applications received will be screened before the conduct of open written competitive examination only with respect to the Driving license authorizing to drive motor cycle, heavy goods vehicles and heavy passenger motor vehicles and the other eligibility conditions as per clause (2) of this notification will be verified after the declaration of open written competitive examination result.

### 3. AGE LIMIT:

Not exceeding 30 years of age as **on 28.02.2025.** Age limit is relaxable for applicants belonging to the categories of OBC, MBC, SC, and In-service officials as detailed below:-

Relaxable for Government Servants up to 35 years (38 years for OBC/MBC and 40 for SC officials) in accordance with the Instructions or orders issued by Central Government, provided such Government servants are working for not less than 3 years in the posts which are in the same line or allied cadres and where a relationship can be established that the services rendered by them in the Department will be useful for efficient discharge of duties in the post for which selection is made.

\*\* Requirement of Age for candidates belonging to various categories are given in Part-II of this Notification.

### 4. EX-SERVICEMEN:

- **4.1 Explanation**: An 'ex-serviceman' means a person :
- 4.1.1 Who has served in any rank whether as a combatant or non combatant in the regular Army, Navy and Air Force of the Indian Union, and
- 4.1.1.1 Who either has been retired or relieved or discharged from such service whether at his own request or being relieved by the employer after earning his pension;

or

4.1.1.2 Who has been relieved from such service on medical grounds
Attributable to military service or circumstances beyond his
control and awarded medical or other disability pension;

or

- 4.1.1.3 Who has been released from such service as a result of reduction in establishment;
  - 4.1.2 Who has been released from such service after completing the specific period of engagement, otherwise than at his own request, or by way of dismissal, or discharge on account of misconduct or inefficiency and has been given a gratuity; and includes personnel of the Territorial Army, namely, pension holders for continuous embodied service or broken spells of qualifying service;

or

4.1.3 Personnel of the Army Postal Service who are part of Regular Army and retired from the Army Postal Service without reversion to their parent service with pension, or are released from the Army Postal service on medical grounds attributable to or aggravated by military service or 8 circumstance beyond their control and awarded medical or other disability pension;

or

4.1.4 Personnel, who were on deputation in Army Postal Service for more than six months prior to the 14th April, 1987;



4.1.5 Gallantry award winners of the Armed forces including personnel of Territorial Army;

or

- 4.1.6 Ex-recruits boarded out or relieved on medical ground and granted medical disability pension.
- 4.2 The applicants who apply under Ex-Servicemen category should necessarily submit the Discharge Certificate & Registration particulars with the Department of Sainik Welfare, Puducherry.
- 4.3 Age relaxation for Ex-Servicemen is not admissible to sons, daughters and dependents of Ex-Servicemen. Therefore, such candidates should not indicate their category as exservicemen.

### 5. NATIVITY / RESIDENCE:

- 5.1 Those who are natives of the Union Territory of Puducherry or who have continuous residence in the U.T. for the last 5 years immediately preceding the date of notification alone are eligible to apply for the posts.
- 5.2 The applicants on selection shall furnish the fresh Nativity/Residence Certificate issued by an Officer of the Department of Revenue and Disaster Management, Puducherry not below the rank of Deputy Tahsildar at the time of certificate verification.

### 6. COMMUNITY CERTIFICATE:

6.1 The selected applicants shall submit a fresh Community Certificate SC/MBC/OBC obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar at the time of certificate verification.

6.2 Candidates selected under SC quota should furnish fresh Community Certificate issued under "The Constitution (Puducherry) Scheduled Castes Order, 1964 "or" The Constitution (Puducherry) Scheduled Castes Order, 2002" in respect of "Puthirai Vannan".

### 6.3. CERTIFICATE FOR EWS CANDIDATES:

The candidates selected under EWS category should submit income & asset certificate obtained in the prescribed form issued by an Officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar at the time of certificate verification. The crucial date for submitting income and asset certificate by the candidate will be 28.02.2025, the last date mentioned in the Notification dated 09.02.2025 of this Department. The certificate should have been issued for the financial year 2023-2024 and shall be valid for the year 2024-2025.

### 7. PERSONS WITH DISABILITY:

The persons with disability are **not eligible** for the of post of J.E/AMVI as it requires driving of motor vehicles both LMVs and HMVs compulsorily, as per the duties and responsibilities of the said post.

### 8. MODE OF RECRUITMENT/PATTERN OF EXAMINATION:-

### a) Written Examination:

The Language of the question Paper I & II is English only.

The vacancies in the above said posts will be filled through a Written Competitive Examination. The Question paper will be of Degree /Diploma Standard of objective type consisting of two papers (Paper-I and Paper – II) with 100 marks each in forenoon and afternoon sessions with duration of 2 hours having 100 questions carrying one mark each.

Negative mark of 0.25 will be awarded for every wrong answer and multiple answers will be treated as a wrong answer. Candidates are, therefore, advised to keep this aspect in mind while answering the questions.



### Weightage of marks:

- (i) 25% Weightage will be given for Paper-I
- (ii) 75% Weightage will be given for Paper-II

Weightage will be given as above on the actual marks obtained by the candidates irrespective of the number of questions evaluated after finalizing the Key Challenge.

Answering would be in the form of shading the correct answer by using **BLACK BALL POINT PEN** only and the applicants are permitted to take the carbon copy of their answer sheet along with their question booklet. The answer key will be published in the recruitment website <a href="https://recruitment.py.gov.in">https://recruitment.py.gov.in</a> after completion of Examination process.

## 9. MINIMUM QUALIFYING MARKS PRESCRIBED FOR THE WRITTEN EXAMINATION:

9.1 A list of candidates will be provisionally shortlisted from the merit list based on the marks obtained by the applicants in the Open Written Competitive Examination subject to reservation as per rules in force. Minimum qualifying marks to be secured by the various categories of candidates are as follows:-

UR : 30% OBC/ MBC/ EWS: 25% SC : 20%

A candidate must appear in both Paper – I and Paper – II to become eligible to be included in the merit list subject to obtaining of minimum qualifying mark prescribed above in each paper (Paper – I and Paper – II) and thereafter, weightage will be given as mentioned at para 8 above.

The Government reserves the right to relax the qualifying marks in exceptional circumstances.

### 9.2 **Resolution of Tie Cases:**

In the event of tie in scores of candidates in the examination, merit will be decided by applying the following criteria, one after another in the given order, till the tie is resolved:

- (i) Date of birth, with older candidate placed higher.
- (ii) Alphabetical order in which the names of the candidates appear.

### Note:

The validity of operation of wait list, if drawn, will be two years from the date of declaration of the result/ publication of select list. The wait list will be operated in the event of occurrence of a vacancy caused in the Select list due to rejection of candidature for non-production of required certificates, non-appearance of candidate for certificate verification, non-joining of candidate within the stipulated time allowed for joining the post or when a candidate joins but resigns or dies within a period of one year from the date of joining etc.

### 10. DATE AND VENUE OF EXAMINATION:

The Open Written Competitive Examination will be conducted in Puducherry region only, tentatively on 16.03.2025 (Sunday) on both sessions. The date and time of downloading of hall ticket will be intimated in the recruitment portal.

### 11. HOW TO APPLY AND LAST DATE FOR APPLICATION:

Applicants fulfilling the eligibility criteria as mentioned above may apply online only through the official website https://recruitment.py.gov.in from 10.02.2025 (12.00 Noon) to 28.02.2025 (03.00 p.m.)

### 12. PROCEDURE FOR SUBMISSION OF ONLINE APPLICATION:

- 12.1 The applicants have to register with their Mobile Number in the online portal "https://recruitment.py.gov.in"for applying through online.
- 12.2 They will receive exclusive Username and Password through SMS in the registered mobile number provided. The applicants may login the online portal using the exclusively allotted Username and Password and shall apply for the post.

- 12.3 The applicants are advised to change the default Password received in their mobile after first login.
- 12.4 It is the applicant's responsibility to maintain the secrecy of the password and it should not be disclosed to anyone.
- 12.5 The applicants may view, print & check the status of their application and download the Hall Ticket by logging in the online portal using the username and password. Hence, they are advised to keep the user name and password safe for future reference until the recruitment process is completed in its entirety.

### 12.6 Photograph & Signature uploading:

- 12.6.1 Applicants shall upload their Photograph and Signature using either option1 (or) option 2 provided in the recruitment portal as given below:-
- 12.6.2 Option 1 (scanned Photograph and Signature as a single image)
  Applicants are instructed to scan their recent passport size colour photograph & signature in an A4 sheet with200 DPI resolution, dimensions should be minimum of 600 x 600 pixel and the file size should be less than 150KB. (as shown in guidelines video for uploading and cropping your photograph and signature during online application)
- 12.6.3 Option 2 (Scanned Photograph and Signature as separate images) Applicants are instructed to scan their Photograph in 3PEG format with 238 x 306 pixel dimension and the file size should be less than 50KB. Signature file format should be JPEG, dimensions should be 350x150 pixel and file size should be less than 30KB.
- 12.6.4 The photograph should have been taken recently, preferably within three months.
- 12.6.5 Read / View the Photograph & Signature (Text / Video) guidelines in the instruction page of the online portal https://recruitment.py.gov.in for guidance.

- 12.7 PREVIEW facility is available to view the details entered and please verify it before submitting the application.
- 12.8 After checking all the information provided, Click SUBMIT button without fail.
- 12.9 If the applicant fails to submit the application by clicking SUBMIT button after PREVIEW, the application will remain in PREVIEW stage only and it will not be considered as a valid application and it will be rejected, for which the Government will not be held responsible.
- 12.10 Candidates whose application remain in **PREVIEW** stage will not be allowed to write the examination.
- 12.11 Even after submission of application, corrections, if any, can be done before the closing date.
- 12.12 Keep a copy of the online generated application for your future reference.
- 12.13 Please logout/sign out after submission of application.
- 12.14 Online generated applications can be viewed in any standard PDF readers.
- 12.15 Please use latest web browser for better compatibility, better user experience and improved security.

- 12.17 The Department does not accept any responsibility for the candidates not being able to submit their applications within the last date on account of the aforesaid reasons or for any other reason beyond the control of the Department.
- 12.18 Application with incomplete data / information and improper photograph and signature is liable for rejection.

- 12.19 The information/data furnished by the applicants in the online application are final and cannot be altered after the closure of the application on 28.02.2025 at 03.00 P.M.
- 12.20 Request for change of date of birth, category, etc. will not be entertained on any account after the date of closure.

## 13. PROCEDURE FOR SUBMISSION OF APPLICATION BY IN-SERVICE APPLICANTS:

Only the candidates working as **Master Mechanic** under the cadre control of Transport Department in the Union Territory of Puducherry will alone be considered as feeder cadre for the post of Junior Engineer / Assistant Motor Vehicles Inspector and allowed to appear as In-service candidates by availing the permissible age relaxation mentioned in the statement under "3. Age Limit" of this notification. Applicants working in the Transport Department and applying as In-service applicant with age concession should forward a copy of the online generated application through their respective Heads of Offices within the due date **i.e. on or before 03.00 P.M on 28.02.2025 to** "The Under Secretary to Government (Tr.)-cum- Deputy Transport Commissioner, Transport Department, 100 Feet Road, O.K. Palayam, Mudaliarpet, Puducherry-605 004".

The application of the In-service candidates which are not duly forwarded by their Head of office within the due date and time of 03.00 p.m. on 28.02.2025 will be summarily rejected. Advance copy of application for In-service candidates will not be entertained.

### PART-I

### 14. GENERAL INSTRUCTION TO THE CANDIDATES

- 14.1 Mode of applying for the open written Competitive Examination for Direct Recruitment to the post of JE/AMVI is only through online. Avoid registering multiple online applications and register only one single application. In case of multiple online applications, only the latest application will be accepted and all other duplicate applications will be rejected.
- 14.2 All candidates who register themselves in response to this advertisement by the closing date and time and whose applications are found to be in order will be provisionally accepted as per the terms and conditions of this Notice of Examination.
- 14.3 Candidates must go through the requirements of educational qualification, experience, age, etc. and satisfy themselves that they are eligible for the post.
- 14.4 The Department will not undertake any detailed scrutiny of applications to check eligibility and other aspects at the time of written examination and, therefore, admission to the examination will be provisional only, which will not confer any right on such provisionally admitted candidates to claim appointment based on such provisional admission.
- 14.5 Candidates are cautioned that they must ensure that they belong to the category as filled in the application form and are able to prove the same by furnishing the requisite certificate from the competent authority when such certificates are sought by this Department at the time of certificate verification, failing



which their candidature will be cancelled. For example, candidate X filled OBC in his application form. However, during certificate verification, he is unable to produce the valid OBC certificate. In such scenario, candidature of X will be cancelled. Hence, candidates are advised to fill the application after ascertaining the category under which the caste he/she claims fall in the state list for OBC, MBC, SC, EWS.

- 14.6 The Candidates who mention their category as MBC-Migrant/OBC-Migrant / SC-others in their online application will be considered only under Unreserved category.
- 14.7 The certificates/documents in support of their educational qualifications, work experience certificates and caste/category, etc. shall be sought from the provisionally selected candidates at the time of Certificate Verification only.
- 14.8 After verification of the certificates/documents of educational qualifications, work experience certificates /caste/category, etc., if any claim made in the application is not substantiated by certificates/ documents, the candidature of candidate will be cancelled/rejected, without any notice.
- 14.9 Admit Card for examination will be issued online on the Website <a href="https://recruitment.py.gov.in">https://recruitment.py.gov.in</a>. Candidates are therefore advised to regularly visit the websites <a href="https://recruitment.py.gov.in">https://recruitment.py.gov.in</a>.
- 14.10 All the communications with regard to this recruitment will be published in the Website <a href="https://recruitment.py.gov.in">https://recruitment.py.gov.in</a>. Applicants are advised to visit the website and watch the news in dailies regularly for information. They are advised to keep the Mobile number given in the online application active for sending SMS connected with this recruitment.

- 14.12(a) "Use of calculator, laptop, palmtop or other digital instruments/mobile/cellphone/communication devices/ electronic devices/pager/Smart watches are not allowed inside the examination Venue. In case any candidate is found in possession of such items he or she would be debarred from the examination and legal proceedings will be initiated against the candidate."
- 14.13 The decision of the Government of Puducherry as to the eligibility or otherwise of the applicant for admission to the Examination shall be final.
- 14.14 A separate press note will be issued in leading regional news dailies regarding the issue of hall tickets through online. The eligible applicants can download their Hall Ticket from the Website <a href="https://recruitment.py.gov.in">https://recruitment.py.gov.in</a> by using the "User Name and Password".

- 14.15 The applicant, after applying can also make corrections in their on-line application, if any error occurred while entering the data. They are allowed to avail this facility till **03.00p.m.** on **28.02.2025**.
- 14.16 The information /data furnished by the applicants in the online application are final and cannot be altered after the last date of applying i.e. **28.02.2025.**
- 14.17 Before submission of the applications / corrected applications, candidates must check that they have filled correct details in each field of the online form. After the closing date for receipt of online application i.e. 28.02.2025, no change / correction / modification will be allowed under any circumstances. Requests received in this regard in any form/manner Post, Fax, E-mail, by hand etc. will not be entertained by this Department and will be summarily rejected.
- 14.18 The applicants are advised to have a copy of the online generated application for their reference.
- 14.19 Applicants except In-Service candidates need not send the printout of the online application or any other supporting documents to this Department.
- 14.20 The candidates applying under the category of In-Service are instructed to submit the online generated application through their respective Head of Office on or before 28.02.2025 (03:00 p.m.).
- 14.21 Candidates seeking reservation benefits available for SC/OBC/MBC/EWS must ensure that they are entitled to such reservation as per eligibility prescribed in the Notification. They should also be in possession of the certificates in the prescribed format in support of their claim.

- 14.22 After scrutiny, the status of the application will be indicated in the Website https://recruitment.py.gov.in. The applicants are advised to check the official website to know their application status.
- 14.23 No correspondence will be entertained with regard to the recruitment process. Candidates are advised to verify the status of their Application/ Hall Ticket etc, through online only.
- 14.24 The admission to the examination is only provisional. Success in the open written competitive examination confers no right to appointment. The appointment is subject to verification of educational qualification /residence /community and any other special category claimed by the individual including medical fitness.
