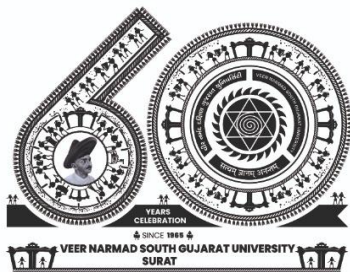

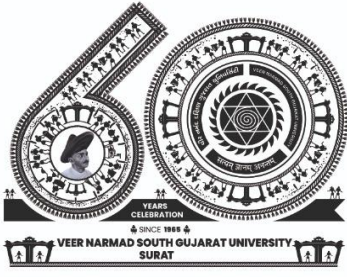

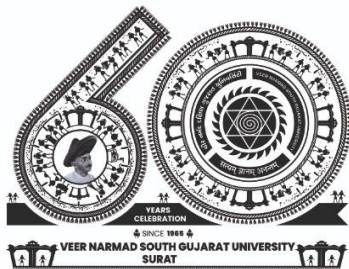

Agreement

Agreement entered into this DAY of DD-MM-YYYY between NAME OF TEMPORARY TEACHING ASSISTANT / TEMPORARY ASSISTANT PROFESSOR (here in after called the Temporary Teaching Assistant /Temporary Assistant Professor of the one part and the Veer Narmad South Gujarat University, being a Body corporate constituted under the Veer Narmad South Gujarat University Act, 1965 (herein after called the University) of the other part).

Whereas by the resolution of the University passed by the Board of Management at its meeting held on the 20/12/2024 it was resolved to appoint Temporary Teaching Assistant/ Temporary Assistant Professor as per requirement of University. Accordingly, Temporary Teaching Assistant / Temporary Assistant Professor appointed in the department of _____/ Self Finance Programme on purely temporary and 11 months contract (completion of second term of academic calendar) subject to the conditions of service as may be laid down by University from time to time. AND WHEREAS the Temporary Teaching Assistant/ Temporary Assistant Professor accepted the said terms of appointment and agreed to join the University service, AND FURTHER WHEREAS it has been considered desirable to record in writing, the terms and conditions of service agreed to between the Teaching Assistant /Assistant Professor and the University.

NOW THESE PRESENTS WITNESS that it is hereby agreed by and between the parties as follows:

- (1) The appointment as a Temporary Assistant Professor / Temporary Teaching Assistant / is purely on temporary bases on contract of 11 months.
 - (i) Your appointment will automatically end on Appointment of GIA/SFT (Permanent) Assistant Professor/ Associate Professor/Professor.
- (2) The appointment will automatically end on completion of 11 months (second term of Academic year 2025-2026) without notice.
- (3) Selected candidate is entitled to get an honorarium of Rs. 40,000/- /Rs. 25,000/- per month or final as per decision of University authority.
- (4) Since this a purely temporary post on contract basis, benefits of provident funds, Gratuity, Leave Travel concession and Medical Benefits etc. shall not be admissible.
- (5) Temporary Assistant Professor / Temporary Teaching Assistant will abide by the conditions of service and discipline rules as laid down by the University from time to time.
- (6) Temporary Assistant Professor / Temporary Teaching Assistant shall not be engaged in any other part time/full time employment without prior permission of University.
- (7) The appointment on a purely temporary basis and can be terminated during assignment of the contract without giving notice or without assigning any reason thereof when your services for teaching or other academic work are not required by the University.
- (8) The appointment is also liable to be terminated at any time if the University is not satisfied with the work or conduct of Temporary Assistant Professor / Temporary Teaching Assistant without giving any notice.
- (9) The appointment shall not confirm any right or entitlement for claiming absorption against any vacancy or post.
- (10) Temporary Assistant Professor / Temporary Teaching Assistant has to keep and maintain strict confidentiality and privacy of information, data and secrets of examination work of the University.
- (11) Temporary Assistant Professor / Temporary Teaching Assistant shall abide by the conditions of service and discipline rules as have been laid down by the university from time to time.
- (12) Temporary Assistant Professor / Temporary Teaching Assistant will be entitled for one (1) leave each month with prior permission of Head of the department.

- (13) Temporary Assistant Professor/ Temporary Teaching Assistant must do teaching and research activities, other academic work/ administrative/ co-curricular and extra-curricular of the University department. There will be performance review of Temporary Assistant Professor every 05 month if performance review does not meet performance your order shall be automatically cancelled.
- (14) Temporary Assistant Professor/ Temporary Teaching Assistant has to produce original certificate and testimonials for verification before joining your duties.
- (15) Temporary Assistant Professor/Temporary Teaching Assistant Temporary Teaching Assistant must do all administrative work from admission to placement.
- (16) Temporary Assistant Professor / Temporary Teaching Assistant are required to maintain a professional dress code that is in keeping with the customs and traditions.
